## Minutes of the Meeting – 13th December 2020

- The meeting commenced with a welcome note by Dr.V.Pavithra, Vice President of the Association. This was followed by the presidential address delivered by Dr.V.Pavithra, on behalf of Dr. Mohan Choudhary, the President of the Association.

- Query on investment by fixed deposit was raised, secretary clarified that fixed deposit will be invested soon after renewal of society registration.
- Mr.B.Subramaniyan requests the last year financial report (2018-2019). Dr.V.Deepa Parvarthi presented the 2018-2019 financial report.
- Dr. Koushik Muthuraja.M, Secretary of the Association requested all the members to give suggestions for future plans.
- Mr. Prasanth Gireesh suggested that alumni can contribute to outreach program and we can conduct a virtual alumni day every year. Dr. Koushik Muthuraja, accepted the suggestion.

- Mr. Subramaniyan, wanted to know plan for the forthcoming year. Dr. Koushik Muthuraja.M, explained that we are planning for more charity related activities. This will be our prime theme of focus.
- Mrs. Rajeshwari Singaravelu, suggested to have the Alumni Guest House. Dr. Koushik Muthuraja.M, explained that we are also planning to have separate alumni building in our college campus.
- Mr.B.Subramaniyan, raised a question on Income and Expenditure Statement towards staff
  welfare expenses mentioned in the financial report. Secretary and treasurer updated that the

  our alumni).
