Minutes of the Meeting – 11th October 2022

- Master of the ceremony was done by Ms.Sivakamatchi.
- The meeting commenced with a welcome note from Dr.V.Pavithra, Vice President of the Association. This was followed by the presidential address delivered by Dr.V.Pavithra, on behalf of Dr. Mohan Choudhary, the President of the Association.
- Prof. P. V. Vijayaraghavan, Vice Chancellor addressed the gathering and emphasized for increased attendance through online participation. He expressed his happiness towards the alumni association's progress over the past two years.
- Prof. K.V.Somasundaram, Professor of Eminence and Advisor(Academics)addressed the gathering and emphasized that Alumni meet should be organized in such a way i.e., more social interactions rather than an academic ones.
- Prof. T.K.Parthasarathy, Director of International Relations addressed the gathering on “Alumni do well, institution do well”. He suggested to organise alumni lounges, and alumni buildings. He also suggested on ‘each member donate one book to library’ and preparation of annual alumni newsletter.
- Dr. Koushik Muthuraja.M, Secretary of the Association presented the annual secretary report. He highlighted the activities including registration of the Association in the Registry of societies, the vision and mission of our association, initiation of the “Alum Book” a social platform for the alumni to register and network, Distinguished Alumni awards, introduction of membership cards for the alumni and the privileges of the card; contribution of the alumni association (towards the alma mater and the society) and events organized by the alumni chapters.
- Dr. Koushik Muthuraja.M, Secretary of the Association presented the proposed changes to Bylaws:
 - Membership fees of Rs.3000/- will be charged to Ph.D. (Full time only) students for obtaining membership in the Alumni association of SRIHER. The option is purely voluntary and not compulsory
 - Only registered members are eligible for application to the Distinguished alumni award
 - Revision Membership fees of Rs.500/- for all the chapters
 - These changes were approved by Dr. Sharada.T.Rajan (Alumni BDS 1999 – 2000) and was seconded by Dr. Rajkumar.M (Alumni BDS 2003 – 2004)

- The financial audit for the financial year 2021-2022 was presented by Dr.V.Deepa Parvathi, Treasurer of the Association. She presented the audit statement of income and the expenditure details of the association for the period of April 2021 – March 2022.
 - The Treasured report was approved by Dr. Manjula A (Alumnae BSc Nursing 2000-2001 & MSc Nursing 2006-2007) and seconded by Dr.Renuka Vidyashankar (Alumnae MBA 2012 – 2013)
- Dr. Koushik Muthuraja.M, Secretary of the Association interacted with the members for queries regarding the secretary report and financial report.
- One of the alumni raised a query on the interest gained through fixed deposits and Dr.V.Deepa Parvathi clarified.
- Dr. V.Pavithra, Vice President of the association presented the future plans of the association and also requested all the members to give suggestions for plans.
- Dr.V.Deepa Parvathi brought to the attention of all the alumni about the initiation of scholarship grants for two post-graduate students and Ph.D. scholars (Full time) who have completed their undergraduate or post-graduation in our institution. All these privileges apply to registered alumni. Eligibility criteria and application forms for the scholarship are posted on the university website.
- Dr.Shanthi from the Faculty of Nursing department suggested sponsoring Gold Medal for the students. Dr.Koushik Muthuraja responded that the alumni association planning for an all-rounder award.
- Dr.Prathiba (Alumnae BASLP 1996-1997 & MASLP 2004-2005) suggested to an alumni day annually. This will facilitate participation of International alumni Dr.Koushik Muthuraja responded that organizing alumni day needs adequate funds and collecting address from all the alumni is quite challenging.
- Dr.Archana (Alumnae MD Pathology 2013-2014) appreciated the alumni association for the social responsibility initiatives and contributions i.e., helping to build toilet facilities in Annambedu village with the collaboration of NSS, distribution of T-shirts during the Yoga day celebration
- Dr.R.C. Perumal, Executive Committee Member, Faculty of SLHS, proposed the vote of thanks and adjourned the meeting.
