## Minutes of the Meeting – 21st December 2023 at University Auditorium, SRIHER

- The meeting commenced with the Presidential welcome address by Dr.V.Pavithra, Vice President of the Association
- Dr. Koushik Muthu Raja M, Secretary of the Association presented the Minutes of the previous year (2021-2022) general body meeting and the action taken. Key points of previous year GBM are:
  - Membership fees of Rs.3, 000/- will be charged to Ph.D. (Full time only) students for obtaining membership in the Alumni association of SRIHER. The option is purely voluntary and not compulsory
  - o Only registered members are eligible for application to the Distinguished Alumni Award
  - o Revision Membership fees of Rs.500/- for all the chapters
- Dr. Koushik Muthu Raja .M, Secretary of the Association presented the annual secretary report. He highlighted the activities including registration of the Association in the Registry of Societies and the vision and mission of the association. Key points of the secretary's report include:
  - Contribution of the alumni association towards the University. Advantage of "Alum Book" app, cards and privileges were explained.
  - Association has donated a sum of Rs. 1, 00,000/- (One Lakh Only) towards Toilet construction (Phase-1)
     For Irular Community, Thirumanam Village, Thiruvallur District, Tamilnadu.
  - Alumni Association has donated a sum of Rs. 2, 00,000/- (Two Lakh Only) towards Scholarship for PG and Ph.D. for the academic year (2022-2023).
  - Alumni Association has included the following new chapters (Engineering, Clinical Research and Audiology).
  - o In the current year, the Nursing Chapter contributed gold medal sponsorship of Rs.2,00,000/-
  - O He glorified the proud moment for SRIHER alumni association on receiving the "6th Medical Excellence Award" from Governor of Kerala.
